What is changing?

New rules set by the European Union (EU) on two substances of concern in food packaging – BPA (bisphenol A) and PFAS (per- and polyfluorinated alkyl substances) – will apply from mid-2026.

Why?

BPA is widely used in varnishes and coatings for food packaging, but can migrate into food. From July 2026, its use will not be authorised in specific food contact materials (adhesives, rubbers, ion-exchange resins, plastics, printing inks, silicones, varnishes and coatings), with some exceptions (Regulation 2024/3190).

PFAS are persistent chemicals that represent environmental and health hazards. From August 2026, strict restrictions will apply to food contact packaging (Regulation 2025/40).

To sell packaged food in the EU, businesses must ensure compliance with these requirements via a declaration of conformity. This is initially drafted by the packaging manufacturer and then shared across the supply chain, and updated if needed.
