The following Protected Designations of Origin (PDOs) and Protected Geographical Indications (PGIs) were registered in the geographical indications register of the European Union (EU) (eAmbrosia) in 2024:

# PDOs:

- "Lada Putih Muntok" from Indonesia
- "Osmaniye Yer FIstIII" from Türkiye
- "Bingöl Ball" from Türkiye
- "Bursa leftalisi" from Türkiye
- "Hüyük Çile■i" from Türkiye
- "Bursa Siyah Inciri / Bursa Siyahl" from Türkiye
- "Gaziantep Menengiç Kahvesi / Gaziantep Melengiç Kahvesi" from Türkiye.

## PGIs:

- "Söke Pamu■u" from Türkiye
- "Manisa Mesir Macunu" from Türkiye
- "Livanjski sir" from Bosnia and Herzegovina.
