Clarification of import requirements for certain animal products

EU clarifies requirements for certain animal products (dairy products, food additives, collagen casings, gelatine capsules) to enter the European Union

Commission Delegated Regulation <u>2025/637</u> of 29 January 2025 amending Delegated Regulation (EU) 2022/2292 as regards the requirements for the entry into the Union of certain dairy products, certain food additives derived from animals, collagen casings, minced meat, meat preparations, mechanically separated meat and composite products containing gelatine capsules

Update

The European Union (EU) has clarified which products of animal origin must meet specific requirements (authorisation of country of export, approval of establishments, health certificates) to enter the EU. It has added Combined Nomenclature/Harmonized System (CN/HS) customs codes defining certain dairy products, food additives, and collagen casings not currently included in the Regulation. In addition, this Regulation establishes that all meat establishments providing raw material for the EU market must be EU approved, and clarifies that no document is required to accompany gelatine capsules not derived from ruminant bones when used in composite products.

Impacted products

Food additives, collagen casings, minced meat, meat preparations, mechanically separated meat, composite products, gelatine capsules

What is changing?

Lists of animal products that must meet specific requirements

Article 3 of Regulation <u>2022/2292</u> presents a list of animal products that may only enter the EU if the non-EU exporting country has been authorised by the EU to export.

Article 13 of that Regulation provides a list of animal products that may only be exported if they come from establishments approved for the EU market.

Both lists define the animal products with reference to customs codes. However, the customs codes for certain categories of animal products were not previously listed.

The new Regulation clarifies which animal products are covered by:

- adding the following to the list of products that can only be imported from authorised non-EU countries: certain dairy products, food additives derived from animals, and collagen casings with the following CN/HS customs codes: 1301, 1806, 3203, 3204, 3823, 3824, 2202 99, 3917 10 10 [Art. 3(b)]
- introducing the following in the list of products that can only be exported from listed establishments: certain dairy products and collagen casings with the following customs codes: 1806, 2202 99, 3917 10 10 [Art. 13(1), a.ii].

Types of establishment that may be listed

Article 15 of Regulation <u>2022/2292</u> specifies the types of establishment that must be approved and listed to provide raw material for the production of fresh meat, minced meat, meat preparations, mechanically separated meat, meat products, and gelatine.

The new Regulation clarifies that the establishments requiring approval include those producing minced meat, meat preparations, and mechanically separated meat, so that all establishments providing raw material, from the slaughterhouse onwards, must be EU approved (Art. 15).

Health certificates

Article 21 of Regulation <u>2022/2292</u> lists the animal products that require official health certificates on export. The new Regulation adds certain dairy products and collagen casings with the following CN/HS codes to the list: 1806, 3302, 2202 99, 3917 10 10.

Gelatine capsules

Certain composite products do not require a health certificate, but do require a private attestation, signed by the operator responsible for the consignment, stating that they meet EU requirements (Art. 22 of Regulation 2022/2292). The new Regulation amends this requirement so that no private attestation is required for composite products where the only animal ingredient is gelatine capsules **not derived from ruminant bones**.

Why?

Certain animal products, such as food additives, dairy products, and collagen casings, are extensively imported into the European Union and must meet EU requirements. The new Regulation adds to Regulation 2022/2292 the customs categories under which they are traded.







Timeline

The new rules apply from 19 May 2025.

What are the major implications for exporting countries?

This proposal provides greater legal certainty about which rules apply to certain dairy products, food additives, and collagen casings. It facilitates the export of composite products in which gelatine capsules not derived from ruminant bones are the only animal ingredient.

Background

Regulation <u>2022/2292</u> sets out the public health requirements for animal products exported to the EU. It aims to ensure that food-producing animals, products of animal origin, and composite products meet requirements that are at least equivalent to the EU public health legislation (as detailed in the relevant <u>official certificates</u>).
