Update

The EU has amended its rules to allow poultry from Brazil imported under a tariff rate quota to be accompanied by a digital certificate of origin. Previously a paper certificate of origin was required; as Brazil now issues these certificates in digital format, the rules have been amended to also allow digital versions.

Impacted products

Poultry from Brazil

What is changing?

Previously, Brazilian exporters of poultry wishing to benefit from the EU tariff rate quota had to provide certificates of origin in paper format (Regulation <u>2020/761</u>). Now, certificates of origin can also be provided in digital format.

A template of the digital certificate of origin is presented in Annex II to the new Regulation.

Why?

The EU is updating its rules in response to countries' transition towards digitalisation of import and export documents.

Timeline

From **23 February 2024**, Brazilian poultry imported under the tariff rate quota may be accompanied by certificates of origin in digital format.

What are the major implications for exporting countries?

The acceptance of digital certificates of origin will ensure smooth and safe trade of poultry from Brazil under the tariff rate quota.
