Update

This Call for Evidence relates to an evaluation of the protocol implementing the EU's Sustainable Fisheries Partnership Agreement (SFPA) with The Gambia. The current protocol expires in July 2025.

Impacted products

Tuna, demersal (bottom-dwelling) fish

What is changing?

A new protocol needs to be negotiated for the EU fleet to fish in The Gambia's waters as soon as possible after the current protocol expires on 30 July 2025.

Why?

The EU fleet cannot fish in waters of The Gambia if there is no protocol implementing the SFPA between The Gambia and the EU [Common Fisheries Policy Basic Regulation <u>1380/2013</u>, Art. 31(5)]. This Call for Evidence aims to ensure that the evaluation and future negotiations on a renewal of the protocol with The Gambia consider the views of stakeholders.

Timeline

The feedback period for this Call for Evidence closed on 26 July 2024.

What are the major implications for exporting countries?

A new protocol would benefit The Gambia's population by providing economic revenue and employment opportunities. Implementing the SFPA promotes good governance and supports the local fishing sector.

Recommended Actions

Feedback on this proposal closed on 26 July 2024 (see <u>EU-The Gambia fisheries agreement</u> - negotiation mandate for an implementing protocol).

Background

The <u>Sustainable Fisheries Partnership Agreement</u> (SFPA) between the EU and The Gambia was concluded in July 2019. The current protocol allows for EU vessels from Spain, Greece, and France to fish in waters of The Gambia, and is part of the tuna network fisheries agreements in West Africa. The Gambia receives €550,000 per year during the 6-year duration of the protocol.

Regulation <u>1380/2013</u> on the Common Fisheries Policy sets out mandatory evaluation requirements for SFPAs. SFPAs ensure consistency between the EU's Common Fisheries Policy and other European policies, including sustainable use of partner country resources; combating illegal, unreported, and unregulated (IUU) fishing; integration of partner countries into the global economy; and better political and financial governance of fisheries.
