## EU sets molasses representative prices and import duties for 2025 marketing year

Commission Implementing Regulation (EU) [2025/2008](#) of 30 September 2025 fixing the representative prices, import duties and additional import duties applicable to molasses in the sugar sector from 1 October 2025

### Update

The European Union (EU) has set cost, insurance, and freight (CIF) representative prices and import duties for cane and beet molasses for 1 October 2025–30 September 2026 (2025 marketing year).

### Impacted products

Molasses

### What is changing?

The European Commission has set the representative price (the CIF import price) of molasses for the period of 1 October 2025–30 September 2026 (2025 marketing year) at:

- €19.57 per 100 kg for molasses from sugar cane (CN code 1703 10 00)
- €16.19 per 100 kg for molasses from sugar beet (CN code 1703 90 00).

The import duty for these products for the 2025 marketing year is zero. This continues the zero duty that was set for the 1 October 2024–30 September 2025 period.

### Timeline

The duty set out in this Regulation applies from **1 October 2025**.

## Background

Regulation [2023/2834](#) sets a 'representative price' for imported molasses covered by CN codes 1703 10 10 (sugar cane molasses) and 1703 90 00 (sugar beet molasses). This is the cost, insurance, and freight (CIF) price based on world market prices (Art. 25). These are fixed for each marketing year (from 1 October to 30 September of the following year) and can be amended by the European Commission. Where this representative price plus the molasses import duty exceeds €8.21 per 100 kg, as is the case for the 2025 marketing year, import duties are suspended or reduced (Art. 8, Regulation [2023/2835](#)).
