What is changing and why?

This report summarises Rapid Alert System for Food and Feed (RASFF) notifications of products entering the European Union (EU) from low- and middle-income countries in January 2026:

- 145 notifications on food products (Table 1)
- 3 notifications on feed (Table 2)
- 8 notifications on food contact materials (Table 3)

originating from 33 [AGRINFO partner countries](#).

Actions

To minimise RASFF notifications and ensure smooth trade with the EU market, producers and exporters from non-EU countries must take action to ensure the safety of their products. This involves implementing rigorous control measures at every stage of production, processing, and packaging to ensure adherence to EU standards and regulations; establishing comprehensive food safety management systems (e.g. Hazard Analysis and Critical Control Points – HACCP) to identify and address potential risks across the supply chain; and maintaining meticulous documentation of all activities to enable traceability and provide evidence of compliance with EU regulations.
