## EU changes representative prices for certain frozen poultrymeat imports from Brazil

Commission Implementing Regulation (EU) [2025/2232](#) of 29 October 2025 amending Regulation (EC) No 1484/95 as regards fixing representative prices in the poultrymeat and egg sectors and for egg albumin.

### Update

The European Union (EU) has changed the cost, insurance, and freight (CIF) representative prices for certain frozen poultrymeat products from Brazil.

### Impacted products

Frozen poultrymeat (chicken carcasses and fowls) from Brazil.

### What is changing?

The European Union (EU) has increased the representative price – the cost, insurance, and freight (CIF) import price – of certain frozen poultrymeat from Brazil (see Table 1).

### Why?

The representative import prices for these products are changed to reflect price variations in the country of production (Brazil).

### Timeline

The revised representative prices apply from **29 October 2025**.

## Background

Regulation [1484/95](#) sets a “representative price” or “trigger price” for poultrymeat and egg products imported into the EU. This is the cost, insurance, and freight (CIF) price based on world market prices. Where the import price falls significantly below the trigger price (at least 10% difference between import and trigger prices), additional import duties can be applied. The level of duty depends on the amount of difference between the two prices (Regulation 1484/95, Art. 4).
