Welcome to Issue 47 of AGRINFO UPDATE. This issue reports on the European Commission's proposal to set maximum levels for inorganic arsenic in fish and seafood. The Commission also proposes to authorise the use of a new source of folic acid, and has published its decisions on certain health claims applications. New Regulations coming into force include the extension of temporary measures on citrus fruits from certain countries, and clarification of the reference methods used for detecting *Trichinella* in pork. The maximum residue levels for difenoconazole were increased on rye and wheat in 2024 but are included in this latest issue following certain clarifications.

We also provide the latest overview of recent food imports found not to comply with EU law and an overview of the planned opportunities to provide feedback on EU policies and regulations under development.

New Regulations coming into force and application dates



Priority pests

EU extends temporary measures on citrus from **Argentina**, **Brazil**, **South Africa**, **Uruguay**, and **Zimbabwe** to avoid introduction of citrus black spot. Applies from **1 April**
