We report on launch plans for the EU's new electronic system for non-customs documents (ELAN), now open for testing, and the updated EU food audit programme for 2025. Over the summer the EU has authorised (among others) a number of novel foods, health claims, and food additives, as well as additional substances that can be used in organic production.

The AGRINFO Team has published a new guidance document on the EU Deforestation Regulation, giving a simple overview of the elements most relevant to non-EU stakeholders.
