There are opportunities for stakeholders to give feedback as the European Union reviews its Fisheries Partnership Agreement with Mauritius, also through the World Trade Organization on clarifications to the list of animal products subject to controls at EU border control posts. Recently published Regulations include trade arrangements for molasses, and improved EU market access for Moldovan products.
