This issue reports on additional EU controls on imports of certain foods from Bangladesh, Egypt, India, Madagascar, Pakistan, Sri Lanka, Thailand, Türkiye, and Vietnam due to concerns about potential health risks. The EU's new <u>Observatory on deforestation and forest degradation</u> provides public access to satellite maps to support operators in demonstrating that commodities are "deforestation free". And the European Commission has notified the World Trade Organization of changes to MRLs on cypermethrin, an insecticide widely used on many crops.

EU proposes to amend the following maximum residue levels (MRLs). WTO SPS consultations – deadline 10 February 2024

- cypermethrins
- difluoroacetic acid
- 1,4-dimethylnaphthalene
- fluopyram
- flupyradifurone

Non-EU countries will be required to list all establishments exporting honey to the EU; some clarifications are made to facilitate trade in products of animal origin. Applies from 18 December 2023, with a transitional period to **29 November 2024** for the listing of establishments that export honey
