This edition includes our latest trade policy digest, highlighting the most significant developments in EU trade negotiations and policy. Also covered are the first in a series of new EU Regulations on animal welfare. For the first time, these rules will address the conditions in which live animals are transported from the exporting country. The EU has also proposed changes to maximum permitted levels for various mycotoxins, which could require significant additional monitoring and control by countries exporting cereals/cereal-based foods. We give links to the World Trade Organization where countries can comment on these new mycotoxin levels, as well as on the non-renewal of certain pesticides, among others.

# Changes notified to World Trade Organization Send feedback via your National SPS/TBT notification authority within the 60-day time limit



#### **Contaminants**

EU proposals on maximum levels – opportunities for feedback to <u>WTO</u> <u>SPS</u> by **4 March 2024**:

- establishing maximum levels for <u>T-2 and HT-2 toxins</u> in cerealbased foods
- reducing maximum levels of <u>deoxynivalenol</u> in cereals/cerealbased foods
- reducing <u>3-MCPD</u> maximum levels in infant formula



#### **Pesticides**

EU proposes not to renew approval of active substances – <u>WTO SPS</u> consultations:

- mepanipyrim feedback by 16 February 2024
- <u>dimethomorph</u> feedback by 21 February 2024



## **Product marketing standards**

EU proposes amendments to Δ-7-stigmastenol limits in olive oil – feedback to EU by 15 January 2024; to WTO TBT by 19 February 2024
