Pesticide MRLs

EU proposes to amend maximum residue levels for the following substances:

- [1,4-dimethylnaphthalene](#) on all plant products except potatoes
- [chlormequat](#) on animal products
- [triclopyr](#) on certain products, with particular impact on citrus fruits
- [metribuzin](#) on cassava roots/manioc, land cresses, and olives (with separate MRLs for metribuzin-DADK)
