- <u>Temporary derogation</u> to allow verification of consignments for import into EU and issuance of certificates of organic inspection to be still based on the equivalence scheme up to 15 October 2025 – <u>Feedback to EU</u> by 11 July 2024
- <u>Recognition of two control bodies</u> for implementing organic controls and certification in non-EU countries under new EU organic legislation – <u>Feedback to EU</u> by **9 July 2024**
