New Regulations coming into force and application dates



Food additives

EU authorises use of the food additive "carbomer" (E 1210) in food supplements. Applies from **21 March 2023**

Common Fisheries Policy

EU prohibits targeted fishing of southern bluefin tuna by EU vessels. Applies from **13 April 2023**



Pesticides

EU has not renewed approval of the active substance oxamyl. **Reduction in MRLs expected for 2024**

New pesticide MRLs

Changes will apply from 13 April 2023 affecting:

- pyridate (chives)
- pyridaben (grapefruits)
- pyriproxyfen (apricots, cherries, apples, pears, quinces, medlars, Japanese medlars, loquats, cranberries, tomatoes, peppers, aubergines, cucumbers, gherkins, okra)





New pesticide MRLs

Changes will apply from **21 October 2023** affecting:

- chloridazon (all products)
- <u>fenpropimorph</u> (all products except bananas)
